Child support may affect your child's eligibility for public benefits including Medicaid. A lawyer may be able to help you set up a special needs trust for your child instead of child support. The TexasLawHelp forms do not include this option. A judge may also order that child support for a disabled child continue after the child becomes an adult.

The legal presumption that the Standard Possession Order is in a child's best interest does not apply when a child is younger than three years old. See Texas Family Code chapter 153.251(d) . If your child is under three, you and the other parent may still agree to use the Standard Possession Order.

If you are not the child's parent, you can file a modification case if: You are listed as a party in the current order. or ; You have had actual care, control and possession of the child for at least 6 months ending not more than 90 days before the date you file the modification case with the court and you are not a foster parent. or

It has been at least three years since the last child support order, and a new support order, based on child support guidelines, would differ from the last support order by at least 20% or \$100.
